

## THE SPRINGS AT STONE OAK OWNERS ASSOCIATION PRIVACY FENCE STAIN COLOR

WHEREAS, The Springs At Stone Oak Owners Association ("Association") is charged with administering and enforcing those certain covenants, conditions and restrictions contained in the recorded Declarations for the various sections of the community (referred to collectively as "Declarations"); and

WHEREAS, the Board of Directors of the Association ("Board") desires to establish a standard for the stain color for wooden privacy fences and to provide clear and definitive guidance to owners.

NOW, THEREFORE, the Board has duly adopted the following privacy fence stain color standard, applicable to Article VIII, Fences.

- 1. The staining of wood privacy fences is an option for each Lot Owner. If stained, the standards provided herein will be adhered to.
- 2. All fences will be stained with only one color stain for continuity. The color selected by the Board will match the perimeter fence and the Park equipment/fence. That color is: Chestnut Brown Cabot Premium Wood Care Semi-transparent Stain. Oil-based or acrylicbased versions of the stain are permissible. For the location of the nearest store selling Cabot stains, see their website at http://www.cabotstain.com.
- 3. All changes of color of stain for fences will be approved in advance by the ARC unless an identical stain is used.

This Policy is effective upon recordation in the Public Records of Bexar County, and supersedes any policy regarding privacy fence stain color standards which may have previously been in effect. All other provisions contained in the Declarations or any other dedicatory instruments of the Association shall remain in full force and effect.
